TERMS AND CONDITIONS OF LICENCE FOR THE IMPORTATION OF FERTILIZER

1. The licence shall not be transferable to any other person shall not be used for the benefit of any person other than the person to whom it was issued.
2. Every licensee shall exhibit the licence issued to him under this Act in a conspicuous position in his place of business.
3. The licensee shall furnish proof of sufficient warehousing and storage space.
4. The licensee shall not, without the prior approval of the Director, sell, transfer or otherwise dispose of any interest in the business covered by the licence, or enter in to any agreement with regard to that business with any other person whereby such other person acquires a proprietary interest in such business.
5. In the event of loss of licence, a certified copy thereof shall be issued by Director on submission of an affidavit by the licensee, attested by a Justice of the peace, confirming the loss and on payment of half the prescribed licence fee.
6. Every licensee who ceases to carry on business for which the licence has been issued or who changes his place of business shall forthwith notify the Director of that fact.
7. The licence issued to an individual shall lapse on the death of the licensee.
8. The licence issued to a body corporate shall lapse on the dissolution of that body.
9. All notices relating to this licence shall be deemed to have been duly served on the licensee if such notice are sent by post or are delivered to the person for the time being in charge of the place of the business or are affixed to the door or the gate thereof.
10. The licence shall be liable for cancellation if information given in the application for licence is found to be false or incorrect.

**** By virtue of issue of this licence, the licensee is committed to carry out all Activities pertaining to the Regulation of Fertilizer Act No. 68 of 1988 and the regulation made thereunder with due diligence and responsibility.**

(note : Renewal of licence A licence may be renewed by the Director for a period or periods not exceeding one year at a time on application made to the Director not less than thirty days before the expiry of the licence)
